I understand that our child's image, name, work product, school and grade may be revealed in the presentation(s), but that no other information about our child or his/her schoolwork will be revealed without prior consent.

This release and consent form acknowledges that all photographic proofs, photographic negatives, positives, and prints shall constitute the property of Our Lady of Mount Carmel School and may be used by Our Lady of Mount Carmel School for any purpose determined at its discretion, without further notice or any compensation to me or to my child.
